

2025 Builder Incentive Program

Incentive amounts are dependent on the Home Energy Rating Score (HERS) and range from \$200 to \$6,550.

Take Action

The Colorado Springs Utilities ("Springs Utilities") Builder Incentive Program ("Program") is designed to encourage Colorado Springs homebuilders to build homes to a higher energy efficiency standard than is required by state and local codes. Incentives are offered on a first come, first served basis and are subject to eligibility and availability of funds. Certain other conditions and restrictions apply. PROGRAM RULES AND QUALIFICATIONS

To participate in the Builder Incentive Program

The Program requires that each builder ("Participant") registers annually, then submits documentation proving each home's Home Energy Rating Score ("Rated Home"), to receive an incentive.

- 1) Review the Program Rules.
- 2) Register for the Program by completing this Annual Participation Application, and include the following documentation:
 - Complete IRS Form W-9,
- 3) To receive an incentive for a Rated Home
 - The Participant must ensure that a Home Report of each completed home is forwarded to NewHomes@CSU.org within 30 days of rating final inspection.
 - Home Report must contain the following items
 - Home Energy Rating Score (HERS) Performance Energy Rating Certificate or Home Energy Rating Certificate (Contains energy component values)
 - ENERGY STAR V3 Home Verification Summary (includes HERS score with and without PV)
 - Certificate for the home building standard achieved.
 - Incentive payments may take 6 to 8 weeks to process.

- The Rated Home is subject to inspection by Springs Utilities staff at any reasonable time with advanced notice. If the home for which an incentive has been issued is found on inspection to not qualify, the incentive amount will be charged back to the Springs Utilities account which was originally credited, and the incentive amount will be collected.
- Incentives are offered on a first-come, first-served basis and are subject to availability of funds.
- Springs Utilities only provides incentives for homes that received the Home Rating through independent verification; homes that receive ratings or certifications through the sampling method will not be eligible.
- The energy rater and rating must meet all RESNET requirements. Rater be qualified and certified to undertake ratings/certifications at the time the rating is conducted.
- Participant is solely responsible for obtaining related building permits and completing the inspection process as required by local jurisdiction.
- Incentive is based on the HERS value without PV generation included.

Builder Incentive

Each Rated Home will be incentivized based on its Home Energy Rating Score (HERS) and technologies included, plus bonuses for additional home certifications. Homes must score a HERS of 60 or below to qualify for incentives and bonuses. HERS is based on calculation prior to including solar PV.

- **HERS incentives begin at \$200 for a score of 60**, additional \$25 per point below, up to a maximum of \$2,250 for HERS 0 (Zero)
 - **Bonus of \$350** for achievement of one or more of the following Home Building Standards; ENERGY STAR, National Green Building Standard, Leadership in Energy and Environmental Design, Passive House.
- **Incentive of \$700** for Energy Star Heat Pump DHW systems with UEF greater than 3
- **Incentive of \$100** per toilet using 0.8 gallons per flush. This offer is applicable for up to 3 toilets in total.
- **Incentive of \$800** for Heat Pump (Heat and Cool) installation instead of an Air Conditioning unit. Requires unit certified Energy Star with minimum 15 SEER, integrated with Energy Star gas furnace for cold temp supplemental heat
- **Additional Incentive of \$3,000** for full electrification of home, requires
 - Cold Climate Heat Pump, NEEP or Energy Star listed, for primary HVAC load
 - Tanked electric, hybrid or Heat Pump domestic hot water <= 5kW
 - No Natural Gas interconnection

General Qualification Requirements

- Home must be a Residential Building, as defined by the 2021 IECC. These includes detached one- and two-family dwellings and multiple single-family dwellings (townhouses) and Group R-2, R-3 and R-4 buildings three stories or less in height above grade plane.
- Rating must be completed by a certified RESNET Home Energy Rater.
- HERS/ERI software must meet the most current active ANSI RESNET Standard.
- Homes with a Certificate of Occupancy awarded prior to Utilities receiving this application, or prior to January 1st of the calendar year do not qualify.
- Annual Participation Application and Home Reports must be received between January 1 and December 31 of the calendar year.
- Incomplete applications and/or those lacking required documentation will be denied.
- Participant must have an active Springs Utilities account at the Certified Home when the Home Energy Rating certificate is received.
- Incentive is only available to homebuilders.
- Each Rated Home is eligible to receive a single incentive through this Program.
- The Rated Home must be in Springs Utilities' electric and gas service areas.
- Gas only customers are eligible for up to seventy (70) percent of qualified incentives. To receive water incentives rated home must be connected to CSU potable water service.
